Description

ASC 911 Silicone Wet Patch is a flashing grade, silicone roof patch designed to be installed in a single application without reinforcement on a variety of substrates. ASC 911 can be used as a long term solution on penetrations, skylights, seams, sealing holes, etc. Superior adhesion and flexibility is weather resistant and withstands extreme elongation. Ideal for use on new and existing roofs and for roof maintenance. ASC 911 is designed to be highly reflective and UV stable with direct exposure to sunlight.

Read and follow directions carefully. Refer to Material Safety Data Sheet for proper handling.

Application

For exterior use only. Protective clothing and eyewear should be used during application of this product. Apply on warm, sunny day preferably in the morning to provide maximum cure time. ASC 911 may be applied to damp horizontal surfaces. Surfaces should be cleaned before application.

ASC 911 can be applied in the Three Course Installation Method using a paintbrush, or trowel. Apply first coat at a thickness of 1/8-1/4 inch (3.2mm-6.4mm). While first coat is still wet, place polyester fabric and brush to remove air pockets and wrinkles. Second layer should be applied immediately at a thickness of 1/8-1/4 inch 1/8-1/4 inch (3.2mm-6.4mm). If needed, trowel ASC 911 over cracks in concrete, masonry, and wood. Additional applications may be necessary, as elastic cement shrinks through drying.

Cleanup

Clean tools with soap and warm water.
